1. Entry will be open to all members of the USBC (United States Bowling Congress). This tournament will be governed by the USBC Playing Rules in Chapter 6 and the rules in Chapter 7, of the USBC Bylaws and Association Policy Manual; however, USBC Rules 319A(2) and 319D will not apply.
2. It shall be each bowler's responsibility to verify the accuracy of their average, whether originally submitted by the bowler or others. Failure to use proper average or to make corrections prior to, or before completion of the first game shall disqualify the score if submitted average is lower than actual average, or base prize winnings on submitted average if it is higher. (USBC rule 319a3)
3. For handicap purposes, the highest book average of 21 games or more from the 2008-2009 winter season will be used. If a bowler does not have a 2008-2009 winter season average, the highest book average of 21 games or more from the 2008-2009 summer season will be used.
 - a. If no book average last year, use highest average of 21 games or more as of January 1, 2010. If no January 1, 2010 average, bowlers must bowl scratch (230). Bowlers not having a USBC yearbook average must submit an average verification and/or current league standing sheet as of January 1, 2010.
 - b. USBC Rule 319d shall apply in this tournament for reporting prize-winning (\$600.00). Average adjustment requirements of USBC Rule 319e shall apply for average under 225. All bowlers who have had their average adjusted by other tournaments in the last 12 months must be reported before the first event bowled in the city tournament.
 - c. Sport league averages will be adjusted as per the sport league average adjustment chart.
 - d. **Tournament Director reserves right to re-rate average based upon information submitted.**
 - e. **USBC Rule 319a2 (10 pin over) DOES NOT apply to this tournament.**
4. **Handicap will be 90% of 230.**
5. Entry fee is \$150.00.
6. **Schedule**

- All entrants will bowl a four game qualifying block, starting Saturday, March 13, 2010 at 9:00am. Check-in will begin at 8:00am. After the four game qualifying round the field will be divided into four 16 team divisions for Match Play. The field will then be cut in half with the 32 winners advancing in the Championship portion and the 32 non-winners going into the "2nd Chance" portion. Match play will continue dividing each portion in half until the top 4 remain in the Championship portion and the top 2 remain in the "2nd Chance" portion. The "Final Four" will be contested to conclusion with the last 2 undefeated bowlers competing for 1st and 2nd.
