- Entry will be open to all members of the Greater Seattle USBC Association and any USBC member in good standing. Every entrant must have a valid USBC membership card. South Sound members **DO NOT** have to pay local fees. Members outside Greater Seattle and South Sound USBC will have to pay local fees. This tournament will be governed by the USBC Playing Rule 319 - Averages.
- For handicap purposes, the previous season's highest average of: a) A single USBC league average based on a minimum of 21 games; or b) A composite average of all USBC leagues, including leagues with less than 21 games bowled, Rule 319a (1). When the previous season's average is used, and at the time of bowling an entrant has a **current average for 21 or more games that is 10 pins or more higher** than the prior season's average, the current average must be used, Rule 319a (2). If no previous season average, use highest average of 21 games or more as of February 8, 2020. If no February 8, 2020 average, bowlers must bowl scratch (225). Bowlers not having a previous season's average must submit an average verification and/or current league standing sheet as of February 8, 2020. **USBC Rule 319d shall apply in this tournament for reporting prize-winnings, \$300.00 or more in any event, total combined prize winnings of \$500.00 or more in any one tournament or total combined prize winnings of \$1000.00 or more in all tournaments within the last 12 months.** Average adjustment requirements of USBC Rule 319e shall apply for average under 225. All bowlers who have had their average adjusted by other tournaments in the last 12 months must be reported before the first event bowled in the city tournament. **Sport/Challenge league averages will be adjusted as per the sport/challenge league average adjustment chart. Tournament Director reserves right to re-rate average based upon information submitted.**
- Entries will be scheduled according to request if possible and in the order received. The schedule will not be changed by the tournament director, except for emergency. The tournament committee reserves the right to cancel a squad if there are less than 12 bowlers for the singles and doubles events and less than 4 teams for the team event. **COMPLETED ENTRY FORMS AND FEES FOR TELEPHONE RESERVATIONS MUST BE RECEIVED WITHIN 5 DAYS OR RESERVATION WILL BE CANCELLED.**
- An entrant may participate in the team event more than once; however, not more than 3 players on one team can place more than once in the prize list for position standings. An entrant may participate in the trio event more than once; however, not more than 2 players on one team can place more than once in the prize list for position standings.
- **The DOUBLES event will be bowled first, immediately followed by the SINGLES event, both events to be bowled on the same pair of lanes.** An entrant may participate more than once in the singles or doubles event; however, in no case shall the same 2-person team be permitted to place more than once in the prize list for doubles event position standings. In no case shall the same individual be permitted to place more than once in the prize list for singles event position standings.
- **OPTIONAL ALL EVENTS (AE):** (Handicap and Scratch Divisions) must be paid before the first event bowled to be eligible. Prize ratio is at least 1-10 for All Events. Handicap All Events score will be based on first score with handicap bowled in the four-member team, doubles and singles events. Scratch All Events will be based on first scratch scores from the four-member team, doubles and singles events. **All Events: entry fee will be \$20.00 scratch, \$15.00 handicap.** All fees for All Events go to the prize fund, returned 100%. **MUST BE MARKED BY ENTRANT'S NAME ON THE TEAM EVENT SECTION OF THE ENTRY FORM.**
